What's New at Marymount?

We are waiting for the release of the EIR

(Environmental Impact Report). The EIR will address the issues respecting Marymount's proposed athletic field. The City staff has a draft report and is presently reviewing it before it is released to the public. This process has been ongoing for about two weeks, but could take several more weeks.

We are hoping this draft report will be available shortly, because we believe the City Council will discuss Marymount by the end of September.

The previous City Council had approved an athletic field requested by (Continued Top Right) Marymount. Subsequently, Marymount changed it's mind and now seeks approval for a field with a different configuration, which is much larger.

The proposed field, if approved, would be situated 60' feet closer to Palos Verdes Drive East. Since the previous field was approved, Marymount joined NAIA (National Association of Intercollegiate Athletics,) which will probably bring many more athletes, students from other schools and spectators to these events.

The EIR should include studies relating to traffic, noise, lighting, parking and the impacts on the surrounding neighborhoods. When the EIR is released to the public, California Law requires the opportunity for public comment, both in writing and orally before the City Council. The public may address its concerns concerning other impacts and (Continued)

CHOA Report

The most recent

meeting of CHOA (RPV Council of Homeowners Associations) was held on June 19. There were three featured speakers from the City: Kathryn Downs, Deputy Director of Finance and Information Technology; Ara Mihranian, Community Development Deputy Director; and Brian Campbell, member of the City Council.

Kathryn Downs provided a financial overview of the City. The annual budget is \$33 million, with \$33.4 million of revenue, no debt, and \$27 million in reserves. There is a 5 year capital improvement plan. In short, the City is in good financial shape. Ms. Downs emphasized that the City encourages citizen input through the Storm Drain Oversight Committee (use of storm drain user fees), the Finance Advisory Committee, and public meetings. All financial documents are on the City website.

Ara Mihranian discussed the Abalone Cove Improvement Project. With a \$330,000 grant from the state and a \$330,000 match from the City, improvements are planned for the 86 acre Abalone Cove area. (continued) There will be new trails, new vegetation, picnic tables, telescopes at the bluffs, and an outdoor classroom. The project is expected to begin this fall and be completed by next spring.

Brian Campbell addressed a number of issues facing the City. Although not located in RPV, the proposed Pointe Vista development off of Western Avenue and the safety status of the butane tanks off Gaffey Street affect RPV, and the City is involved in discussions about these projects. He updated CHOA on the status of Marymount, the construction under way at San Ramon Canyon, and concerns about safety and crime. He also pointed to the success of Terranea which provides the City with 18% of the general fund budget.

The next CHOA meeting is scheduled for September 18.

Back to School



A Safe Place to Learn

There is a lot that can be done by school officials to plan for disasters, to limit the risk, to protect the safety of students and teachers, and to ensure that schools recover quickly. However, the clock is ticking. The time to prepare is right now.

Many states now require specific disaster preparedness activites in their school systems. In California, for example, schools are required to have a disaster plan, to hold periodic "Drop, Cover, and Hold On" drills and to hold educational and training programs for students and staff. Whether mandated or not, all schools should have an emergency response plan that addresses the following:

- □ Identification of hazards and steps to reduce the risk
- \Box Evacuation plans and routes

- Needs of students and staff with disabilities
- Onsite shelter plans
- Emergency supplies and equipment
- Plans for releasing students and school personnel
- Communication

Parents should know the policies and procedures of their children's school during times of disaster or crisis. Parents should also make sure the school has their updated emergency contact information. Keep your children's school emergency release card current.

While planning for a future disaster may seem overwhelming, it is not impossible, and the benefits far outweigh the time and trouble it takes to prepare a school plan.

It is also important for schools to plan in advance to deal with the problem of psychological trauma after a disaster. Signs to look for include withdrawn and/ or more aggressive students, those acting overly responsible or parental, children who are edgy, jumpy, quick to anger, out of control or with a noncaring attitude. Encourage teachers to discuss these and other changes in behavior with parents.
